

## City of Rancho Cucamonga Parkway Restrictions

- Must follow all City codes; for any clarification contact the City's Planning department at: (909) 477-2750.
- Residents are not required to apply for any type of City permit/review to redo the parkway.
- **Allowed alternatives to turf shall consist of:**
  - Low water use planting, excluding cactus, roses and all other plants that contain sharp, pointed and thorn type plant structures.
  - Low water use turf alternatives (groundcovers and grasses).
  - Decomposed Granite (DG) and stabilizer installed appropriately in accordance with City Standards.
  - Wood Mulches, Barks and Chips installed appropriately in accordance with City Standards.
  - Synthetic turf installed on permeable surfaces, but not with tree root protection zone described in the installation section.
- **Prohibited parkway landscaping materials:**
  - Bare dirt without aesthetic improvements
  - Concrete and or anything impermeable, permanent, or fixed in place
  - Cobble (1 inch or larger), pea-gravel, pebbles, or rock
  - Pavers, except when used to provide a walking path from the curb to the sidewalk. A walking path within the parkway should not exceed 24 inches in width as measured from the curb.
  - Gravel (any smooth rock, or any textured rock less than  $\frac{3}{4}$  inch in size or classified for purchase as less than  $\frac{3}{4}$  inch)
  - Stones or Rocks larger than 1 inch in size or classified for purchase as 1 inch or greater.
  - Examples of permitted gravel. Many come in a variety of sizes, but be sure to order  $\frac{3}{4}$  inch.
    - $\frac{3}{4}$  in. California Gold

- ¾ in. Palm Springs Gold
  - ¾ in. Apache Brown
  - ¾ in. Apache Sunset
  - ¾ in. Barkwood
- Gravel installation – permitted gravel shall be installed just below sidewalk and curb level, using the sidewalk and curb to create a border to prevent the gravel from migrating onto streets or sidewalks. Gravel shall be installed to a minimum depth of 2 inches.
- **Parkway Tree Retention Guidelines:**
  - If existing street tree is present, it must be protected at all times and properly irrigated by either microspray or drip system to ensure the life of the tree.
  - If existing street tree is present it must be protected at all times prior, during and after.
  - No excavation of soil from either side or around the tree, within six (6) feet from the outer edge of the trunk I----o----I.
  - No cutting and removing of roots within that same six (6) feet from the outer edge of the trunk.
  - Supplemental irrigation must remain or be installed in the remaining tree root protection zone, either by a microspray or drip system to ensure the life of the tree.
  - Wood Mulch, Bark or Chips need to be dispersed as a cover to the tree root protection zone.
- **Overall Visible FRONT YARD Requirements**
  - Max 50% Impermeable Hardscape
  - Min 25% Plant Material or Artificial Turf
  - Max 25% Decorative, Permeable Hardscape

## Address Eligibility

Due to the City's water retention master plan, some Rancho Cucamonga Residents are not eligible to participate in CVWD's Parkway Turf Replacement Rebate Program.
